

TERMS OF TRADING

It is a condition of Bulldog Products Ltd that all business transacted is subject to our terms of trading.

1. PRICES

- a) Goods will be invoiced at the price ruling on day of despatch
- b) Suggested retail prices include VAT if applicable. Please enquire about quantity terms/promotions
- c) On all bulk packs the recommended retail price is per kilo.

2. DISCOUNTS (ORDER VALUES)

- a) Order Value excl VAT **£250 - £499** Discount = Price Band 1
- b) Order Value (@ Discount prices) **excl VAT £500 – £749** Discount = Price Band 2
- c) Order Value (@ Discount prices) **excl VAT £750 – £999** Discount = Price Band 3
- d) Order Value (@ Discount prices) **excl VAT £1000+** Discount = Price Band 4
- e) Settlement of Pro-Forma orders is strictly COD, whereupon they will qualify for an additional discount of 1%, after which a credit charge of 10% per month shall be applied.
- f) Discount cannot be given if any other account is outstanding
- g) Cheques which fail presentation will be subject of a £10 charge on each failure. There will be a further charge of £20 on the final failure. Also any discounts taken will be disallowed. Further orders will be accepted on a CASH ONLY basis.
- h) Midland Debt Collectors Ltd will be employed to collect monies overdue.

3. RESERVATION OF TITLE

Until Bulldog Products Ltd have received payment in full for the goods and of all other sums whatsoever owed for the time being to the Company by the buyer

- a) The property to the goods shall not pass to the buyer and the buyer shall keep the goods as bailee returning them to the company upon request.
- b) The buyer may sell the goods but the benefits and proceeds of any such sale shall be held upon trust for the Company absolutely

4. CARRIAGE – Revised due to increased fuel surcharges etc..

- a) The minimum order to qualify for carriage paid is as follows:

Scotland (Excluding Highlands & Islands)	£400
Devon, Cornwall, Mid/West Wales, N Ireland	£400
Dublin Area	£400
Scottish Highlands, Channel Islands & S Ireland	£600
All other areas	POA

ADDITIONAL CARRIAGE CHARGES

TIMED DELIVERIES WILL BE CHARGED AT AN **EXTRA £10.00** PER PALLET/TONNE

NEXT DAY DELIVERIES (where applicable) WILL BE CHARGED AT AN **EXTRA £15** PER PALLET/TONNE

FOR DELIVERIES SHIPPED VIA OUR OWN TRANSPORT: Orders will be despatched within a maximum of 5 working days from receipt of the order.

FOR DELIVERIES SHIPPED VIA A THIRD PARTY CARRIER: Orders will be despatched within 8 working days from receipt of the order. These times do not apply to own label, please enquire

5. CLAIMS

Damaged goods and shortages **MUST** be notified to the driver when delivering or phoned to the Sales Office on the day of delivery otherwise claims **cannot** be accepted. Damages on deliveries arriving via a third party carrier **MUST** be marked on the delivery note. Once the driver has left your premises we **cannot** entertain any claims for damaged goods.

6. V.A.T VAT will be charged at the prevailing rate, except for those items marked “*” being zero rated and offshore accounts. * **indicates those items that are zero-rated**

7. NEW ACCOUNTS

Please give the name and address of your bankers and two trade references to open an account. If sufficient credit references are not substantiated by RBSCS then the Company reserves the right to decline a trading account. The Company also reserves the right not to open a trading account if it is to the detriment of the Company.
